**Subject:-** Essentiality Certificate to increase the seats of B.D.S. Course from 60 to 100 of Luxmi Bai Institute of Dental Sciences & Hospital, Patiala.

In continuance of Govt. letter No. 2/17/99-11BIII/6558 dated 21.7.99 on the subject cited above.

2. No Objection /Essentiality Certificate is issued in favour of **Luxmi Bai Institute of Dental Sciences & Hospital, Patiala** to increase the B.D.S. Seats from 60 to 100 at **Luxmi Bai Institute of Dental Sciences & Hospital, Patiala** subject to the following conditions:-

- i) The Institute will obtain recognition/affiliation from the Dental Council of India, New Delhi/Baba Farid University of Health Sciences, Faridkot before making admissions.
- ii) No admission shall be made without the prior approval of Punjab Government for which the Institute will request the State Government.
- iii) The admission shall be done as per criteria fixed by Punjab Govt. from time to time.
- iv) The reservation of seats shall be as per Punjab Government instructions issued from time to time.
- v) The pay scales and emoluments of their staff shall be as per Punjab Government pay scales.
- vi) The inspection of the institute shall be carried out on yearly basis upto the completion of the study of first batch of the students. Thereafter, the inspection shall be periodical after three years.
- vii) The project is to be implemented as per the approved project report within the prescribed time.
- viii) The Punjab Government will have the right to withdraw the N.O.C. if the Society/applicant fails to meet any of the conditions of NOC.

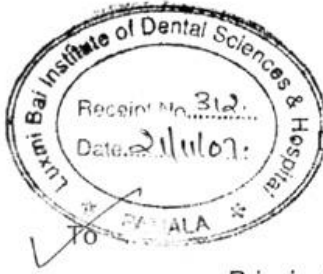
